You may revoke your consent at any time.</p> <p>The processing of personal data within the framework of the fulfillment of contracts to which you are a party, or for the implementation of pre-contractual measures, which take place at your request, takes place on the basis of Art. 6 para. 1 lit. b GDPR. The purposes of data processing depend on the content of the contract agreed in each case.</p> <p>If the processing of personal data is necessary to fulfill a legal obligation, to which our company is subject, Art. 6 para. 1 lit. c GDPR serves as the legal basis.</p> <p>If the processing is necessary to safeguard a legitimate interest of us or a third party and if the interests, fundamental rights and fundamental freedoms of you as the data subject do not outweigh the first interest, Art. 6 para. 1 lit. f GDPR serves as the legal basis for the processing.</p>

In addition, your personal data may be stored if the European or national legislator has provided for this in EU regulations, national laws or other regulations to which we are responsible. If the data is no longer required, or if a storage period prescribed by the aforementioned standards has expired, your data will be deleted regularly.</p>

What rights do you have?	<p>You have the right:</p>

As a result, we may no longer continue the data processing based on this consent in the future;• to request information about your personal data processed by us in accordance with Art. 15 GDPR. In particular, you may request information on the processing purposes, the category of personal data, the categories of recipients to whom your data have been or will be disclosed, the planned storage period, the existence of a right of rectification, deletion, restriction of processing or objection, the existence of a right of complaint, the origin of your data, unless it has been collected from us, as well as the existence of an automated decision-making process including profiling and, if applicable, meaningful information on its details; • in accordance with Art. 16 GDPR, to immediately request the correction of incorrect or incomplete personal data stored by us;• to demand the deletion of your personal data stored by us in accordance with Art. 17 GDPR, unless the processing is necessary for the exercise of the right to freedom of expression and information, for the fulfilment of a legal obligation, for reasons of public interest or for
