#### For what purpose is your personal data used? (Purpose of the data processing Article 13 para. 1 c. GDPR)

Admission decision for access to plant premises, name comparison with legal sanctions lists, site evacuation, investigation of criminal offences and administrative offences, enforcement or defence of claims

#### Legal legitimation for data processing

The processing of your personal data takes place on the basis of the EU General Data Protection Regulation (GDPR) and the Federal Data Protection Act (BDSG). If you have given us permission to process personal data for specific purposes, Article 6 para. 1 lit. a GDPR serves as the legal basis for the processing of personal data. A given consent can be revoked by you at any time. The processing of personal data within the framework of the performance of contracts to which you are a party or for the implementation of pre-contractual measures which take place at your request takes place on the basis of Article 6 para. 1 lit. b GDPR. The purposes of the data processing are dependent on the respectively agreed contract content. If the processing of personal data is necessary to fulfil a legal obligation to which our company is subject, Article 6 para. 1 lit. c GDPR serves as the legal basis. If the processing is necessary to safeguard a legitimate interest of ours or a third party and if the interests, fundamental rights and freedoms of you as the data subject do not outweigh the first-mentioned interest, Article 6 para. 1 lit. f GDPR serves as the legal basis for the processing.





# Interests affected by the balancing of interests (Article 13 para. 1 d. GDPR)

Depending on the situation, the following interests may be affected:

- Performance of contractual obligations
- Assertion of legal claims and defence in legal disputes
- Ensuring site security; site evacuation
- Prevention/avoidance/clarification of criminal offences and misdemeanours

## Any other recipients of the personal data (Article 13 para. 1 e. GDPR)

We may only pass on data to recipients within and outside the Kaman Group if this is necessary, if this is required by law, if you have consented to this, or if contract processors commissioned by us pursuant to Article 28 GDPR have contractually undertaken to comply with the requirements of the GDPR and the Federal Data Protection Act. Such agencies gain access to your data only to the extent that they are required within the scope of "Least Privilege" and the "Need-to-Know" principle. Under these conditions, recipients of personal data may be, in particular, internal or external:

- o responsible internal departments and external service providers as required
- o fire brigades, police authorities, other emergency services
- o providers to carry out name matching against legal sanctions lists
- o solicitors

#### Any other recipients outside the EEA (Article 13 (1) f. GDPR)

To the extent permitted by law your data may also be passed on to other group companies of the Kaman Corporation, 1332 Blue Hills Avenue, Bloomfield, CT, USA. Contracts were concluded with these companies on the basis of the EU standard contractual clauses pursuant to Article 46 (2) lit. c EU-GDPR.

#### How long do we retain your personal data? (Article 13 para.2 a. GDPR)

We process and store your personal data as long as they are necessary for the fulfilment of the respective purpose. In addition, storage can also occur if this has been provided for by European or national lawmakers in Union regulations, laws or other regulations to which we are subject as the responsible party. If the data is no longer required, or if a retention period prescribed by the aforementioned standards has expired, your data will be periodically deleted.

#### From which data sources do we collect data about you? (Article 14 para. 2 f. GDPR)

# What rights do you have?

You have the right

- pursuant to Article 7 para. 3 GDPR at any time to revoke your consent once given to us, provided that we work on the basis of consent. The consequence of this is that we may no longer continue the data processing based on this consent for the future,
- o pursuant to Article 15 GDPR, to request information about your personal data processed by us. In particular, you may request information about the processing purposes, the category of personal data, the categories of recipients to whom your data have been or will be disclosed, the planned storage period, the existence of a right to rectification, deletion, restriction of processing or objection, the existence of a right of complaint, the origin of your data, unless it has been collected from us, as well as the existence of an automated decision-making process including profiling and, if applicable, meaningful information on the details of which
- o pursuant to Article 16 GDPR, to demand immediate rectification of inaccurate or incomplete personal data stored by us
- pursuant to Article 17 GDPR to demand the deletion of your personal data stored by us, unless processing is necessary for the exercise of the right to freedom of expression and information, for the fulfilment of a legal obligation, for reasons of public interest or for the assertion, exercise or defence of legal claims
- pursuant to Article 18 GDPR to demand the restriction of the processing of your personal data insofar as the correctness of the data is disputed by you, the processing is unlawful, but you refuse its deletion and we no longer need the data, but you need it to assert, exercise or defend legal claims or you, pursuant to Article 21 GDPR have raised an objection against the processing
- pursuant to Article 20 GDPR to receive your personal data, which you have provided to us, in a structured, common and machine-readable format or to request the transmission to another responsible person, and
- pursuant to Article 77 GDPR to complain to a supervisory authority. As a rule, you can contact the supervisory authority of your usual place of residence or workplace or our company headquarters.

## Do we use your personal data for automated decision-making? (Article 13 para. 2 f. GDPR)

We do not use fully automated decision-making in accordance with Article 22 of the GDPR and, in principle, no "profiling". If we should use this in individual cases, we will inform you separately about this, if this is legally prescribed, and if necessary, obtain your prior consent.

# Is there a legal or contractual obligation to provide personal data or is this necessary for the conclusion of a contract? (Article 13 para. 2 e. GDPR)

For the purpose of visiting our site, you are contractually obliged to provide the personal data necessary for the unambiguous identification of your person or to which we are legally obliged to collect.





What consequences will there be if you do not provide us with the required data? (Article 13 para. 2 e. GDPR) Without the provision of this data, we may not be able to grant you access to the site.
